COUNSELLING-CUM-ADMISSION SESSION

- Students are required to appear personally for counselling. However, in case any student has to appear in a final examination or is facing an extreme hardship, he/she has to seek permission of the Chairman-UBS, in advance, with documentary evidence of permitted, he/she can send an authorized representative carrying an authority letter from with authentication of the signature of the authorized representative.**
- Original degrees and marks sheets of 10th, 12th and Graduation (all semester/communicative Mark sheets) should be brought. If result of graduation has not been declared, a Character/Bonafide Certificate from the last institution attended MUST be produced. It is absolutely necessary to produce the result of qualifying exam by **July 31, 2022 by 12.00 noon** unless otherwise extended. In case any student will not be able to submit proof of having qualified all the requisite conditions. His/her admission shall automatically stand cancelled.**
- Original and appropriate certificate (as per format given in the UBS Handbook of Information 2022) for claiming reservation under a category must be produced.**
In case the candidate desires Hostel accommodation, he/she would need approximately Rs. 12,000/- * to be deposited subject to availability of seats in order of Merit as well as category wise. (* Tentative)

FEE STRUCTURE Other than Foreign Nationals/NRI

1. The candidates will have to deposit **Rs. 14,375 [Rs. 58,490/- for MBA (EP)]** (1st semester) **through online portal available at <https://payonline.puchd.ac.in> (Fee Code: T0470)** Or in the form of DD in favour of REGISTRAR, PANJAB UNIVERSITY, CHANDIGARH, payable at Chandigarh, as payment of first installment of tuition fee and other University charges (fee under revision*). **However, the applicants would be required to give an undertaking that they would pay the difference consequent upon fee revision for academic session 2022-2023 alongwith the fees for the second semester.**
2. The candidates will have to deposit **Rs.1000/- through online portal available at <https://payonline.puchd.ac.in> (Fee Code: R0080)** Or in the form of DD in favour of REGISTRAR, PANJAB UNIVERSITY, CHANDIGARH, payable at Chandigarh and will be charged extra i.e, Migration Fee and other charges from those students **who are coming from other universities.**
3. Further, the candidates will have to deposit another **Rs. 19,000/-** per annum in form of DD in favour of CHAIRMAN, UNIVERSITY BUSINESS SCHOOL, PANJAB UNIVERSITY, CHANDIGARH, payable at Chandigarh, towards Summer Placement, Teaching materials and Computer Charges etc. **OR Transfer the same** in the Account of Chairman, University Business School, Chandigarh as given below:

FEE STRUCTURE Foreign Nationals/NRI

1. The candidates will have to deposit **US\$ 7500** per year in the form of DD in favour of REGISTRAR, PANJAB UNIVERSITY, CHANDIGARH, payable at Chandigarh, as payment of first installment of tuition fee (fee subject to revision*). **However, the applicants would be required to give an undertaking that they would pay the difference consequent upon fee revision for academic session 2022-2023 alongwith the fees for the second year.**
2. The candidates will have to deposit **US\$ 1000** in the form of DD in favour of REGISTRAR, PANJAB UNIVERSITY, CHANDIGARH, payable at Chandigarh and will be charged extra i.e, Migration Fee from those students **who are coming from other universities.**
3. The candidates will have to deposit **Rs. 6,965/-** in the form of DD in favour of REGISTRAR, PANJAB UNIVERSITY, CHANDIGARH, payable at Chandigarh, will be charged for other charges.
4. Further, the candidates will have to deposit another **Rs. 19,000/-** per annum in form of DD in favour of CHAIRMAN, UNIVERSITY BUSINESS SCHOOL, PANJAB UNIVERSITY, CHANDIGARH, payable at Chandigarh, towards Summer Placement, Teaching materials and Computer Charges etc. **OR Transfer the same** in the Account of Chairman, University Business School, Chandigarh as given below:

The eligibility of candidates shall be provisional at every successive stage of admission process.
