
- 1. Students are required to appear personally for counselling. However, in case any student has to appear in a final examination or is facing an extreme hardship, he/she has to seek permission of the Chairman-UBS, in advance, with documentary evidence of permitted, he/she can send an authorized representative carrying an authority letter from with authentication of the signature of the authorized representative.
- 2. Original degrees and marks sheets of $10^{\rm th}$, $12^{\rm th}$ and Graduation (all semester/communicative Mark sheets) and all other relevant documents should be brought.
- 3. Original and appropriate certificate for claiming reservation under any category must be produced.

FEE TO BE DEPOSITED AT THE TIME OF COUNSELLING-CUM-ADMISSION SESSION

The candidates will have to deposit **Rs. 30790/-** for M.Com (Hons.) &**Rs. 71370/-** for MBAfEX through online portal available at https://payonline.puchd.ac.in (Fee Code: T0470) and as tuition fee (The students of SC (Punjab) whose annual income is less than Rs.2.50 lakh can pay admission fee Rs. 300/-) (1st semester) in the form of DD in favour of REGISTRAR, PANJAB UNIVERSITY, CHANDIGARH, payable at Chandigarh, as payment of first instalment of tuition fee and other University charges (fee under revision*). However, the applicants would be required to give an undertaking that they would pay the difference consequent upon fee revision for academic session 2022-2023 along with the fees for the second semester.

- 1. The candidates will have to deposit Rs.1000/- through online portal available at https://payonline.puchd.ac.in (Fee Code: R0080) Or in the form of DD in favour of REGISTRAR, PANJAB UNIVERSITY, CHANDIGARH, payable at Chandigarh and will be charged extra i.e, Migration Fee and other charges from those students who are coming from other universities.
- 2. Further, the candidates will have to deposit another Rs. 15,500/- for M.Com (Hons.) and Rs. 11,500/- for MBAfEX per annum in form of DD in favour of CHAIRMAN, UNIVERSITY BUSINESS SCHOOL, PANJAB UNIVERSITY, CHANDIGARH, payable at Chandigarh, towards Summer Placement, Teaching materials and Computer Charges etc. **OR Transfer the same** in the Account of Chairman, University Business School, Chandigarh as given below:

The eligibility of candidates shall be provisional at every successive stage of admission process.
