2. Further, the candidates will have to deposit another Rs.19,000/- in form of DD in favour of **CHAIRMAN, UNIVERSITY BUSINESS SCHOOL, PANJAB UNIVERSITY, CHANDIGARH**, payable at Chandigarh, towards Summer Placement, Business club, alumni relations, case unit and Computer Charges.
3. The candidates will have to deposit Rs. 1000/- in the form of DD in favour of **REGISTRAR, PANJAB UNIVERSITY, CHANDIGARH**, payable at Chandigarh, will be charged extra, i.e, Migration Fee, Enrolment Fee and Registration Fee from those students who are coming from other universities.

COUNSELLING-CUM-ADMISSION SESSION

1. Candidate is required to appear in person for counseling to seek admission on the date and time mentioned above.
2. Original degree(s) and mark sheet(s) of 10th, 12th and qualifying examination should be produced at the time of Counselling. If result of qualifying examination has not been declared, a Character Certificate from the last institution attended by the candidate **MUST** be produced. It is necessary to produce the result of qualifying exam by **August 31, 2019 by 12.00 noon**. In the absence of proof of having qualified with requisite percentage of marks, the admission granted shall automatically stand cancelled.
3. Original and appropriate certificate (as per format given in the Handbook of Information) for claiming reservation under a category must be produced by the concerned candidate. Affidavit in the prescribed format must also be produced where required.

The eligibility of candidates shall be provisional at every successive stage of admission process. It will be the responsibility of the candidate to make sure about his/her eligibility and fulfillment of various conditions for admission as prescribed in the University Handbook of Information 2019 and as per other Rules & Regulations of the University. Admission can be cancelled at any stage in case the candidate is found to be ineligible.

After admission, a Migration Certificate would be required from the University/Institution last attended by the candidate in case the admitted candidate belongs to an institution other than Panjab University, Chandigarh.
