**PAYMENT OF FEES BY THE PROVISIONALLY SELECTED CANDIDATES**

All the provisionally selected candidates for the various MBA Programmes under various categories are required to deposit their fees latest by 11.08.2020, 5.00 P.M. and fill in the payment details <https://forms.gle/Q4dzpQJyW2D3at948> (Applicable to Indian Students) As a documentary proof for having deposited the fees.

**FEES STRUCTURE : The selected candidates have to deposit the following fees.**

**1. Tuition Fee**

**(a) MBA, MBA (IB), MBA (HR)**

The candidates will have to deposit **Rs. 12805/-** as tuition fee (1<sup>st</sup> semester) through online portal available at <https://payonline.puchd.ac.in> as payment of first installment of tuition fee and other University charges. (fee under revision).\*

**(b) MBA (EP)**

The candidates will have to deposit **Rs. 54888/-** as tuition fee (1<sup>st</sup> semester) through online portal available at <https://payonline.puchd.ac.in> as payment of first installment of tuition fee and other University charges. (fee under revision)\*

**2. Migration fee (if applicable)**

A migration fee of **Rs.1000/-** will be charged extra through online portal available at <https://payonline.puchd.ac.in> i.e., (Migration Fee and other charges) from those candidates who have not passed qualifying examination from Panjab universities (fee under revision\*).

**3. Summer Placement, Case Unit, Business Club, Computer Charges and Alumni Relations etc.**

Further, all the candidates will have to deposit another fee **Rs. 19,000/-** per annum towards Summer Placement, Case Unit, Business Club, Computer Charges and Alumni Relations etc. This fee is to be deposited in the Account of Chairman, University Business School, and Chandigarh as given below:

## **FEE STRUCTURE FOR FOREIGN NATIONALS/NRI TO BE PAID THROUGH DEMAND DRAFT**

- (i) The candidates will have to deposit **US\$ 7500/- (Total Annual Fee)** per year through demand draft in favour Registrar, Panjab University, Chandigarh-160014, India as payment of first installment of tuition fee and other University charges (fee under revision\*).
  - (ii) The candidates will have to deposit **Rs. 1000/-** through demand draft in favour Registrar, Panjab University, Chandigarh-160014, India will be charged extra i.e., Migration Fee and other charges from those students who are coming from other universities (fee under revision\*).
  - (iii) The candidates will have to deposit **Rs.6,865/-**through demand draft in favour Registrar, Panjab University, Chandigarh-160014, India for other charges (fee under revision\*).
- 4.** Further, the candidates will have to deposit another fee **Rs. 19,000/-** per annum towards Summer Placement, Case Unit, Business Club, Computer Charges and Alumni Relations etc. This fee is to be deposited through demand draft Chairman, University Business School, Panjab University, Chandigarh, India

**The eligibility of candidates shall be provisional at every successive stage of admission process.** It will be the responsibility of the candidate to make sure about his/her eligibility and fulfillment of various conditions for admission as prescribed in the University Business School (UBS) Handbook of Information 2020 and as per other Rules & Regulations of the University. Admission can be cancelled at any stage in case the candidate is found to be ineligible.

**After admission, a Migration Certificate would be required from the University/Institution last attended in case the admitted candidate belongs to an institution other than Panjab University, Chandigarh.**

\*(Fee for the Academic Session 2020-2021 yet to be finalized by the PU Authorities).

\*\* The admission of all the candidates is subject to their producing all the requisite certificates/qualifying result and all the other required documents before the last date fixed for it, which will be intimated later on.

\*\*\* If any candidate becomes ineligible on account of his/her not fulfilling any of the requisite requirements/qualification/eligibility conditions, his/her admission will automatically stand cancelled.

\*\*\*\* All the provisionally admitted candidates will have to submit an undertaking (alongwith proof of deposition of fees) that he/she is fully responsible to produce all the required documents, in original, as and when will be required by Panjab University/UBS.

\*\*\*\*\*If any provisionally selected candidates does not deposit requisite fee by 11.08.2020, 5.00 P.M. and submit the proof thereof by 8.00 P.M 11.08.2020, his/her seat will be offered to the candidate next in waiting list.
