PAYMENT OF FEES BY THE PROVISIONALLY SELECTED CANDIDATES

All the provisionally selected candidates for admission to M.Com (Hons.) under various categories are required to deposit their fees latest by 12.011.2020, 03:00 P.M. and send email at arubs_pu@pu.ac.in (with particular of candidate) as a documentary proof for having deposited the fees.

FEES STRUCTURE: The selected candidates have to deposit the following fees.

1. Tuition Fee

(a) M. Com (Hons.)

The candidates will have to deposit **Rs. 29730/**-as tuition fee (1st semester) through online portal available at https://payonline.puchd.ac.in (Fee Code: T0470) as payment of first installment of tuition fee and other University charges. (fee under revision).*

(Note: The students of SC (Punjab) whose annual income from all sources is less than Rs. 2.50 lakh can pay admission fee Rs. 295/-)

2. Migration fee (if applicable)

A migration fee of **Rs.1000**/-will be charged extra through online portal available at https://payonline.puchd.ac.in (Fee Code: R0080) i.e., (Migration Fee and other charges) from those candidates who have not passed qualifying examination from Panjab universities (fee under revision*).

3. Business Club, Alumni Relations, Case Unit, Computer Charges and contingency etc.

Further, all the candidates will have to deposit another fee **Rs. 15000/-**per annum towards Business Club, Case Unit, Alumni Relations, Computer Charges and contingency etc. This fee is to be deposited in the Account of Chairman, University Business School, Chandigarh as given below:

*The eligibility of candidates shall be provisional at every successive stage of admission process. It will be the responsibility of the candidate to make sure about his/her eligibility and fulfillment of various conditions for admission as prescribed in the Handbook of Information 2020 and as per other Rules & Regulations of the University. Admission can be cancelled at any stage in case the candidate is found to be ineligible.

After admission, a Migration Certificate would be required from the University/Institution last attended in case the admitted candidate belongs to an institution other than Panjab University, Chandigarh.

*(Fee for the Academic Session 2020-2021 yet to be finalized by the PU Authorities).

- ** The admission of all the candidates is subject to their producing all the requisite certificates/qualifying result and all the other required documents before the last date fixed for it, which will be intimated later on.
- *** If any candidate becomes ineligible on account of his/her not fulfilling any of the requisite requirements/qualification/eligibility conditions, his/her admission will automatically stand cancelled.
- **** All the provisionally admitted candidates will have to submit an undertaking (along with proof of deposition of fees) that he/she is fully responsible to produce all the required documents, in original, as and when will be required by Panjab University/UBS.
