PAYMENT OF FEES BY THE PROVISIONALLY SELECTED CANDIDATES

All the candidates who are selected out of the provisional merit list for admission to M. Com (Hons) under various categories will be required to deposit their fees on or before 26.09.2021 up to 03:00 p.m. and also send the payment receipt at arubs_pu@pu.ac.in as a documentary proof for having deposited the fees.

FEES STRUCTURE: Other than Foreign Nationals/NRI

The selected candidates will have to deposit the following fees.

1. Tuition Fee

(a) M. Com (Hons)

The candidates will have to deposit **Rs. 29760/- (Fee Code: T0470)** as tuition fee (The students of SC (Punjab) whose annual income is less than Rs 2.50 lakh can pay admission fee **Rs 300/-**) (1st semester) through online portal available at <https://payonline.puchd.ac.in> as payment of first instalment of tuition fee and other University charges.

2. Migration fee (if applicable)

A migration fee of **Rs.1000/-(Fee Code: R0080)** will be charged extra through online portal available at <https://payonline.puchd.ac.in> i.e. (Migration Fee and other charges) from those candidates who have not passed qualifying examination from Panjab University, Chandigarh.

**3. Summer Placement, Case Unit, Business Club, Computer Charges and Alumni Relations etc.
(for all category candidates)**

Further, all the candidates will have to deposit another fee **Rs. 13,000/-** per annum towards Summer Placement, Case Unit, Business Club, Computer Charges and Alumni Relations etc. This fee is to be deposited in the Account of Chairman, University Business School, Chandigarh as given below:

- (a) Account No.10444984074**
- (b) IFSC Code No. SBIN0000742**
- (c) Branch code 0742.**
- (d) State Bank of India, Panjab University, Chandigarh**

The eligibility of candidates shall be provisional at every successive stage of admission process. It will be the responsibility of the candidate to make sure about his/her eligibility and fulfilment of various conditions for admission as prescribed in the Panjab University Handbook of Information 2021 and as per other Rules & Regulations of the University. Admission can be cancelled at any stage in case the candidate is found to be ineligible.

After admission, a Migration Certificate would be required from the University/Institution last attended in case the admitted candidate belongs to an institution other than Panjab University, Chandigarh.

* The admission of all the candidates is subject to their producing all the requisite certificates/qualifying result and all the other required documents before the last date fixed for it, which will be intimated later on.

** If any candidate becomes ineligible on account of his/her not fulfilling any of the requisite requirements/qualification/eligibility conditions, his/her admission will automatically stand cancelled.

*** All the provisionally admitted candidates will have to submit an undertaking (along with proof of deposition of fees) that he/she is fully responsible to produce all the required documents, in original, as and when will be required by Panjab University/UBS.

****If any provisionally selected candidate is not able to deposit the requisite fee and submit the proof thereof on or before 26.09.2021 up to 03:00 p.m. it would be considered that he/she has declined the offer and his/her seat will be offered to the candidate next in the merit list.
